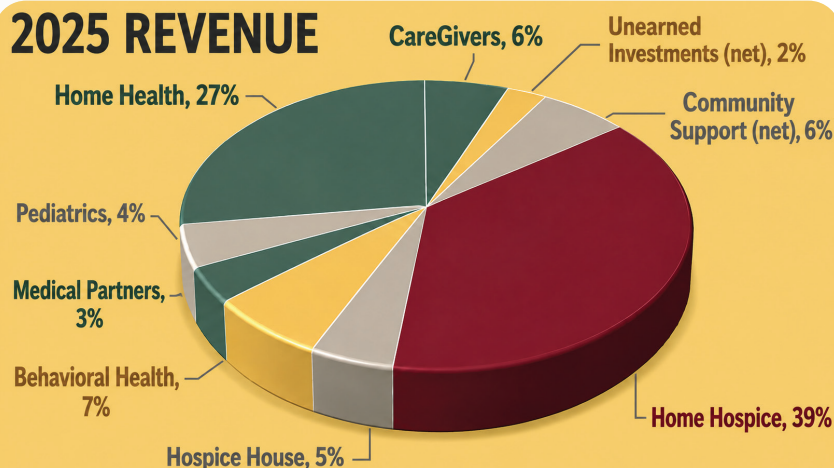

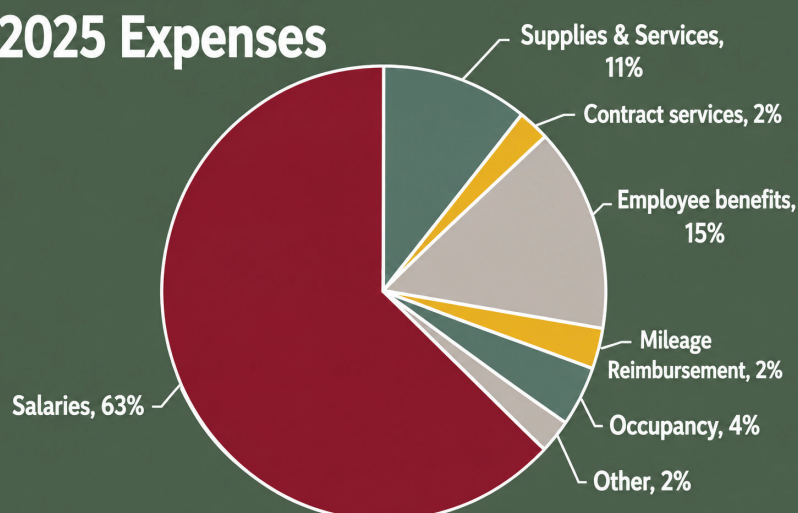

Thoughtful Renovations, Meaningful Impact

One of the most meaningful projects our supporters made possible this year was the rejuvenation of our Hospice House. For patients and families facing life's final chapter, this is more than a building, it is a place where comfort, connection, and lasting memories are created together.

This year, patient rooms have been thoughtfully refreshed with new beds, soft seating, warm lighting, updated window treatments, and welcoming furnishings. The entrance and fireplace have also been renewed, creating an environment that feels peaceful from the moment families arrive. Every improvement was made with the intention of providing comfort, dignity, and a sense of home during an incredibly difficult time.

With the support of our community partners, the Hospice House has been transformed into a space that brings peace, comfort, and dignity when every moment and every detail matters most.

Viera's Determined Steps

When Viera was born in 2017, she was a happy, healthy baby. After a devastating injury changed the course of her life, she was diagnosed with cerebral palsy and now also lives with vision and speech challenges. Despite the obstacles she faces, Viera's determination, resilience, and joyful spirit shine through at every Andwell therapy session.

Because of the generosity of Andwell supporters, our therapy team was able to purchase a specialized gait training system that is helping children like Viera build strength and independence. The system provides the support she needs to practice walking safely along the hallway or on a treadmill, while encouraging natural movement and confidence. Every step she takes is another milestone toward greater mobility and independence.

"The LiteGait equipment has been incredibly helpful for Viera," says Lisa Janke, Pediatric Therapy Preceptor. "She's really come a long way. I've known her since she was about two months old, and her determination and positive attitude have played a huge role in her progress."



For Viera, progress isn't measured only in steps. It's found in growing confidence and the excitement of achieving goals that once seemed out of reach. Now, children like Viera have access to innovative therapy and specialized equipment that empowers them to keep moving forward, one determined step at a time.

Calvin's Journey Forward

At just five years old, Calvin needed bilateral hip surgery to improve his mobility and quality of life. But before the procedure could take place, his family faced an unexpected obstacle. The specialized equipment he would need to recover safely at home was beyond their means. Without it, his surgery would have been postponed indefinitely.

Thanks to Andwell's Life Happens Fund, families can access essential items that make care, recovery, and daily life possible when cost would otherwise stand in the way. For Calvin, that meant his surgery could move forward without delay.

Andwell provided a wagon with the secure harness Calvin needed to travel safely while wearing his post-surgical cast, as well as a large beanbag chair that gave him a comfortable place to rest and recover surrounded by the love of his family. These practical items made all the difference, ensuring Calvin could return home safely after surgery and begin his healing journey.



“We could not find a wheelchair anywhere with a harness on it,” says Calvin’s mother, Tammy. “Laura helped us find the wagon, which had the harness he needed and was the right width because of the cast on his leg. If it wasn’t for you [Andwell] helping us, he probably wouldn’t have had surgery yet. It was a very important thing for our family.”

Sometimes, the greatest impact comes from meeting a simple, immediate need. Through the Life Happens Fund, the generosity of our supporters helps remove financial barriers that stand between patients and the care they need. This support helped turn uncertainty into hope, ensuring Calvin could receive the surgery he needed and begin his journey toward recovery.

In recognition of his extraordinary dedication, Andwell Health Partners proudly presented Brian with the Robert D. Turcotte Memorial Award, honoring individuals who have made an outstanding contribution to home healthcare and hospice.

Brian's story is a powerful reminder that even in life's most difficult moments, compassion has the ability to create hope. Through his volunteer service, he is helping countless others find healing just as he once did.
